 - Information needed from Karen
 - Issue – families not notified of missing information until a denial is received.
 - Lack of communication between applicant & OPWDD
 - Families left out of communication

Karen stated her issue from last month had been resolved.

Achieve – Shannon Westbrook – via email

- Day Hab
 - Two individuals in process who are waiting on paperwork to begin services
 - Three additional referrals under review but program is at capacity currently
- Continued improvements being made on Day Hab space
 - Flooring replaced
 - Environment brighter, cleaner and more welcoming
- State Audit

- Participants remain busy in the community
 - Various outings & volunteer opportunities
 - Bowling, art studio classes, park visits, visits to local community centers
