Topic: Director's Report – Sarah Begeal

Discussion:

- Budget
 - Trending well except Criminal Psych is over for 2026
 - Legislation on Governors desk regarding 730 competency restoration
 - Currently have one admitted individual at approximately \$40,000 per month

- Staffing
 - Anna Walter started 8/24/26 = Supervising Clinical Social Worker
 - Riley Lenetsky starting 9/21/26 – Clinical Social Worker
 - Three interns
 - Matthew McDoanld – MH
 - Zainab Sheikh – School-based
 - Candon Westervelt – School-based
- Safety Training
 - Disaster Mental Health training held 8/25 – 8/26/26
 - Staff certified as a Mental Health Disaster Team
- LSP (Local Service Plan)
 - Plan submitted; approved in July
 - Full plan development next year
- AOT Program
 - New manual created and plan approved
 - Resolution in September to hire an AOT Coordinator
 - Huge increase in AOTs from previous years
 - July & August – 3 new, 2 pending and 1 in EVA
 - BGH screening everyone coming in
- OASAS Name Change for 822 clinics
 - Outpatient Services with OTP (Opioid Treatment Program)
 - OPT must carry Methadone
 - Clinic currently does Suboxone
 - Not seeing a lot of need in Tioga County for Methadone
- Children's SPOA
 - Receiving new money for the Children's SPOA program
 - New list of work scopes created
 - May need to dedicate 1 FTE (full-time employee)
- Medicaid Changes
 - Recertifications every 6 months instead of annually
 - Look back payments 30 days instead of 90 days
 - Payments could be affected
- Affordable Housing Coalition
 - Liz Myers, Commissioner of DSS created coalition
 - Please contact her if interested in being involved
- Subcommittee Separation
 - Goal is for better attendance & discussion
 - Meeting schedule starting in October

- Attending a D3 event on 9/26/26 (DBL, Dream & Do Organization) at Corning Community College
- Action Club has an event today at noon at Hickories for new officer installation

ASAP Report

- Kristin Russell reported the CARA Grant has ended
 - They have reapplied but no word yet
- Adding school meetings and action planning for 2027
- In year 9 of the DFC Grant
 - Sector Reps almost filled – waiting for two people
- In year 4 of the STOP ACT Grant (last year)
 - Looking to reapply
- Summer Family Friendly Events successful
 - Movie nights
 - 30 family packs of tickets for the Tioga County Fair given away
 - Over 400 surveys completed at events
- Youth Advisory Council (youth lead) being developed
- OD Vigil was postponed due to weather. Looking to reschedule

CASA-Trinity

- Jessica Fierro present representing Trinity
- The Owego office has moved to Elmira
- Two school employees are still with Trinity
 - Josh is in the Waverly Schools
 - Kim is in the Spencer Van Etten Schools
- Intervention in Tioga Central Schools done
- New programming being introduced in schools
- 17 Teen Intervenes done across various schools
- Blues Program (more Mental Health skills based) will be in Spencer Schools

Coroner/EMS

- Bob Williams reported Will Ellis will be the EMS contact until Corrine returns
- EMS classes have started
- LEPC meeting was co-chaired by Public Health
 - Representatives from the DEC & National Weather Service presented
- TAM trainings will include both Broome & Tioga Counties
- Coroner Report – 3 overdose deaths through June

- One was a Morphine & Fentanyl combination
- Mental Health

A New Hope Center

- Sarah DiNunzio reported the Domestic Violence Shelter is full (9 beds)
- Primary source of funding is through the NYS Office of Victim Services
 - Funding is competitive
 - Funding decisions are all application based
 - Tioga County did not receive increased funding but had no major cuts
 - Broome County had a 70% cut
- A New Hope Center currently has an Intern from Binghamton University
- Safe Harbor – currently gearing up for school groups
 - Grade level education & programs
 - Spencer VanEtten, Newark Valley, Candor
- Safe Harbor Team met in August and is looking for more partners including youth representation
- October is Domestic Violence Awareness Month – information forthcoming
- Open House for A New Hope Center's 40th Anniversary October 2nd, 2026
 - 20 Church Street from 4:00-7:00pm
 - Chance to win an overnight stay at Belva Lockwood

Rehabilitation Support Services (via email)

- Front Street CR is full (10 beds) with 5 individuals on a waiting list
- Tioga Apartment Program is full (9 beds) with one visitor starting 9/1/26
- Tioga Supported Housing has 21 of the 22 beds full
- Megan Zobel hired to manage the Apartment Program & Supported Housing starting 9/7/26
- Social Club and Drop-in Center welcoming referrals

Public Health

- Katie Wait shared the Suicide Prevention Coalition applied for a capacity grant
 - Suicide safety planning for schools
 - Access to Lethal Means
- Race Dedication Night at Tioga Downs this Saturday 9/5/26

Hea Hea

- Nadia Constant & Georg Oswald reported having 6 patients from February – June
- Numerous struggles have forced them to close for now
- Current situation is not sustainable
- Looking into various alternate cash flow opportunities
- Looking forward to serving patients in some capacity.
