Note from the Public Health Director

Reflecting on 2024, it was a remarkable and productive year at Public Health. We set records by losing only one permanent full-time employee and welcoming five new team members. Notably, we added a Director of Environmental Health, which significantly enhanced the oversight of that division.

The creation and implementation of our agency's Strategic Plan provided a valuable roadmap for how we operate both internally and in terms of the quality of the programs and services we offer to the community. Building off our 2023 theme of "Reset. Renew. Reimagine." we achieved many notable milestones. For instance, we can now accept credit card payments online, and instituted electronic forms, making our services more accessible through technology and our new "Public Health on the Go" mobile trailer.

Our Quality Assurance/Quality Improvement Program led numerous initiatives, including additional program auditing, select project improvements, and the creation and update of internal work procedures. Other key highlights include updates to both the Tioga County Sanitary Code and the Environmental Fee schedule, the first updates in over 20 years.

Public Health assumed leadership of the Tioga County Advocacy, Support, And Prevention Coalition (ASAP), managing grant funds and workplans for substance use and misuse prevention efforts. Through our own Opioid Overdose Prevention Program and the work of these grants and Coalition, we have trained and distributed Narcan to hundreds, added additional locations for Public Access Narcan boxes, a NY Matters vending machine, created several commercials, and launched various forms of advertising in the community.

I would be remiss if I didn't mention the support of the Board of Health, in issuing the order deeming the Foundry/Tioga Castings site uninhabitable due to soil safety concerns. This several-month-long process affected our department in numerous ways and required cooperation from several partners and the community. We express our sincere gratitude to everyone involved in this initiative, helping us carry out our mission to protect the health and safety of those affected.

As we look to the coming year, we will continue to focus on ensuring we have a strong, dedicated

workforce committed to providing quality programs and services to meet the needs of our community.

Using grant funding, we purchased a small supply of permethrin to give each site so their employees could treat their gear.

2024 Public Health Highlights

SUBSTANCE USE PREVENTION

Tioga County Advocacy, Support, and Prevention (ASAP) Coalition

In April 2024, Tioga County Public Health took the lead on the Tioga County ASAP Coalition, which brings together agencies, schools, community members, and more to address substance use related issues in the County.

• DFC Grant (Drug Free Communities)

Grant Focus: Cannabis, alcohol, nicotine, and prescription drugs. **Grant Activities:** Providing information to parents, supporting healthy family activities, reviewing/supporting policies, and providing trainings and technical assistance on prevention efforts in community agencies and schools.

• <u>CARA Grant (Comprehensive Addiction and Recovery Act)</u>
<u>Grant Focus:</u> Opioids, prescription drugs, and methamphetamine.
<u>Grant Activities:</u> Distributing lock boxes, support Drug Take Back Days and providing Public Access Narcan (PAN) boxes to community entities.

• STOP Act Grant (Sober Truth on Preventing Underage Drinking)

<u>Grant Focus:</u> Underage drinking and LGBTQ+ youth. <u>Grant Activities:</u> Compliance checks, supporting after prom events, and providing education to bars and restaurants.

Drug Take Back Day

In 2024, Tioga County Public Health, Tioga County Sheriff's Office, and the Tioga ASAP Coalition hosted two Prescription Drug Take Back & Sharps Disposal Days at the Health & Human Services Building in Owego and at the Waverly Police Station.

These events give community members

the opportunity to dispose of any over the counter or prescription drugs in a safe manner.

Lead Renovator Training

In June, we hosted a free Lead Renovator Training, that gave eight local contractors, property owners, code enforcers, etc. an opportunity to become certified in the Environmental Protection Agency's Lead Renovation, Repair, and Painting Program. This certification is required for any work that may disturb lead-based paint in homes, childcare centers, and preschools built before 1978.

The course was sponsored by Cornell University and taught by Art Wheaton, Director of Labor Studies at Cornell University ILR School Buffalo Co-Lab.

PUBLIC HEALTH STRATEGIC PLAN

Over the course of the year, public health staff have been working in teams to make department-wide improvements divided into four main objectives!

Taxpayer Value

Goal: Communicate taxpayer value through Public Health messaging.

Outcome: Developing plans to educate decision-makers and the general public on the importance of prevention initiatives and the savings associated with them. An infographic describing how Public Health services benefit taxpayers was created, which will complement future presentations and learning sessions.



Community Partnership

Goal: Identify public health partners and establish collaborations to promote healthy living.

Outcome: A Tioga County Public Health postcard and brochure were developed, so that when meeting with partner agencies we could share our department's services in a clear and concise manner.

Outcome: Our Public Health Director, and additional representatives from our team, met with a total of 24 partner agencies to promote collaboration and establish partnerships. These meetings provided a great opportunity for us to reconnect with other local agencies that do important public health work in our community.

Workforce

Goal: Develop an employee training needs assessment to serve as a baseline for training needs.

Outcome: An employee training needs assessment was developed and completed by all members of the department. Feedback from the assessment was used to establish a plan to ensure all staff members receive the training they need to thrive in their positions.

Goal: Develop an employee engagement satisfaction survey.

Outcome: An employee engagement survey was developed and completed by all members of the department. Feedback from the survey was shared with the management team and a plan was established to promote employee satisfaction and retention.

Accessibility

Goal: Develop an assessment to determine Public Health services needed in the community and what should be accessible online.

Outcome: A needs assessment survey was developed and shared with partner agencies. The purpose of the survey was to gather feedback on services that are missing or lacking in Tioga County; for example, access to prenatal care. Results from the survey will be used to guide new initiatives and programs put forth by Public Health.

Goal: Increase accessibility by leveraging technology to provide greater access to public health services/programs online.

Outcome: To increase accessibility, all forms utilized by Public Health are now available online. Our department has also begun using MuniciPay, an online payment program, to make electronic payments accessible to those paying fees in our programs.

COVID AFTER ACTION REPORT

Following the COVID-19 pandemic, our department felt it was critical to take a look at the mitigation efforts of not only the Public Health department, but Tioga County and key partner agencies as well.

We gathered feedback from our department, Tioga County department heads and leaders, and key partner agencies. The feedback was used to determine what was handled efficiently and effectively during the COVID-19 pandemic, so we can duplicate those efforts in the future. More importantly, we used the feedback to identify opportunities for improvement so that we can improve our performance should a similar event happen again.

NYS PUBLIC HEALTH EDUCATORS MEETING

In February, the Health Education team hosted the New York State Health Educators Meeting. We presented on our Monthly Theme Game Plan that we developed to coordinate our outreach and education efforts within the community.

Over 80 health educators from across the state came together to share ideas and suggestions on ways to improve and expand messaging and outreach efforts.

DENTAL PROGRAM EVALUATION

The Dental team hosted grant evaluators from Eastern Tennessee University. They visited our dental program to learn how the funds we received from the Appalachian Regional Commission benefited the community.

The visit included interviewing program participants, school administration, county department staff, as well as members of the Public Health team.

The evaluators were very happy with what they heard and shared positive feedback regarding the program's ability to address dental needs in Tioga County.

CPR INSTRUCTOR

Our Public Health Nurse is now a certified cardiopulmonary resuscitation, or CPR, instructor.

We can now train staff and Medical Reserve Corps volunteers on how to perform lifesaving CPR!

She taught her first CPR class in December!



SCHOOL NURSE MEETING

A meeting was held with school nurses to inform them of any changes in immunization requirements for school. We shared updated resources - the required immunizations for school list, the immunization handbook, and guidelines according to NYS immunization regulations.

The meeting served as an opportunity for school nurses to ask questions and gain clarification on any anticipated questions that might come up during the school year.

This year, we covered topics that we hadn't in years past like communicable disease updates, new internal staff/leadership changes, and updates regarding the dental van.



NEW YORK STATE EI-HUB

The Early Intervention (EI) team has been busy with the transition to the new New York State EI-Hub application. Members of our administrative and EI teams have spent time learning and preparing for the new application.

Unfortunately, the application has come with many challenges that have impacted health departments across New York State. We are hopeful NYS will address the reported issues and the application will be running smoothly in 2025.

The EI-Hub application is used to report child information throughout the EI process, from referral to transition, including managing provider data, provider management, claims creation, billing, and payments.

Communicable Disease

RABIES POST-EXPOSURE PROPHYLAXIS OUTREACH

Our Public Health Nurse provided education on the proper use and administration of rabies post-exposure prophylaxis (PEP) to local emergency department staff at Guthrie Lourdes, UHS Wilson, UHS Binghamton General, Cayuga Medical, and Guthrie Robert Packer Hospital. She shared guidance from New York State, as well as a "cheat sheet" of do's and don'ts for Rabies PEP. The goal of these meetings was to increase knowledge on the proper use and administration of Rabies PEP.

Rabies PEP is a highly effective preventative treatment for individuals who were bitten or scratched by an animal confirmed to have rabies or where a rabies exposure cannot be ruled out.

CLIA LICENSE

Our Public Health Clinic once again has a Clinical Laboratory Improvement Amendments license, or CLIA license!

Having this license gives our clinical staff greater opportunities to protect the community against public health threats! For instance, with this license we would be able to collect specimens in the event of an outbreak.

CLIA certification is required for any facility that performs laboratory testing on human specimens for: diagnosis, prevention, and treatment of disease.





MEDICAL RESERVE CORPS

Our Public Health Nurse and Emergency Preparedness Coordinator have been working hard to make updates to our Medical Reserve Corps, (MRC) attending multiple trainings and conferences, and tabling at local community events to recruit new members.

Updates have also been made to our MRC playbook that encompasses everything that is needed to run Tioga County's MRC!

The Medical Reserve Corps is a network of volunteers who help communities prepare for and respond to public health emergencies and disasters.

LOCAL CODE ENFORCEMENT MEETING


In November, we held a workshop titled "Working Together - Public Health & Code Enforcement" for local code enforcers, town/village mayors, and town clerks.


Through partnership with Stray Haven we held 10 rabies clinics and vaccinated

UPDATED SANITARY CODE

2024 SOLAR ECLIPSE

Handwashing

We visited Head Start classrooms and a Family Resource Center playgroup for a handwashing activity. Children practiced washing their hands using sensory bags filled with hair gel and beads or "germs." Using bottle brushes, they learned how hard they need to scrub their hands with soap and water to

get the germs off! This activity tied into our Lead Poisoning Prevention grant, as handwashing is a method of risk reduction.
